RESOLUTION OF THE SAN BENITO COUNTY BOARD OF SUPERVISORS ADOPTING THE SAN BENITO COUNTY 2024 FEE SCHEDULE FOR THE COUNTY CLERK, RECORDER, AND ELECTIONS DEPARTMENT

WHEREAS, pursuant to the provisions outlined in Government Code Section 54985(a) and Revenue and Taxation Code Sections 408-409, the County has the authority to judiciously adjust service fees to offset the expenses incurred in delivering said service; and

WHEREAS, the adjustments are intended to ensure that the County recuperates its expenditure associated with each service provided. Additionally, proposed fee modifications seek to strike a harmonious equilibrium between the County's incurred costs and the services rendered; and

WHEREAS, to bolster the general fund, the County intends to introduce services permissible by state statute but presently unavailable in San Benito County. This initiative not only aligns with statutory obligations but also augments the department's resource pool; and

WHEREAS, in addition to these endeavors, the County Clerk-Recorder/Registrar of Voters seeks authorization to provide Document Notarization services, a move intended to enhance community services and contribute supplemental revenue to the general fund; and

NOW, THEREFORE, BE IT RESOLVED that the San Benito County Board of Supervisors approve the fee adjustments to the County Clerk, Recorder, and Elections Department fee schedule, located in Appendix A of San Benito County Codes Section 5.01.000; and authorize the implementation of services permissible by state statue but presently unavailable in San Benito County.
